

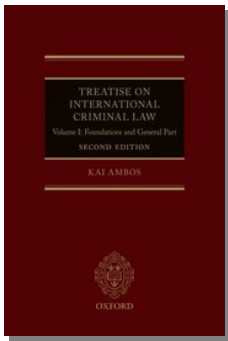

In December 2017 he was appointed as Advisor (Amicus Curiae) to the Colombian Special Jurisdiction for Peace. He is Director of the "Centro de Estudios de Derecho Penal y Procesal Penal Latinoamericano" (CEDPAL) of GAU, life member of Clare Hall College, Cambridge, and external member of the Law Faculty of the University of Lisbon.

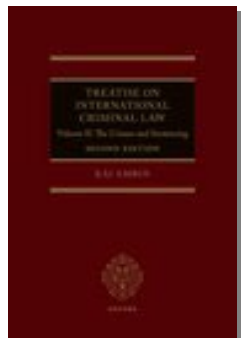

Amongst other updates, there are significant extensions of the discussion on sexual and gender-based crimes; the introduction of environmental crimes into international criminal law; further elaboration on the nexus requirement in war crimes and asymmetrical conflicts (e.g., ISIS); and reference to the newly introduced war crimes of the ICC Statute and of the peculiarities of cyber-attacks and other emerging activities. The volume complements Volume I of the treatise on issues relevant to the foundations, general part of international criminal law, and general principles of international criminal justice.

Taken together with the other new editions of the three-volume series, this second edition provides an exhaustive guide to every aspect of international criminal law, from fundamental principles to procedures and implementation. Kai Ambos' Treatise remains an indispensable reference work for academics and practitioners of international criminal law.
